MEMBERSHIP: Must be a current member of the USATT or affiliated ITTF Organization. USATT membership includes a sanctioned tournament rating and a bi-monthly magazine; it can be purchased through the tournament entry form.

ENTRY DEADLINE: All entries must be postmarked by 09/03/08; late entries and walk-ins will be subject to a \$5 late fee and will only be accepted if there is space available. Entries will be limited to the first 36 players to enter.

REGULATIONS: All USATT regulations apply; only USATT-approved equipment may be used.

VENUE: Tables are Joola 3000SC, floor is concrete, lighting, space around tables and ceiling height are excellent.

EVENT: All matches will be 3 out of 5 games to 11 points. This is a Giant Round Robin event. preliminary RR groups of 5-6 players (determined by USATT rating) followed by a 2nd RR of 5-6 players (determined by the results of the 1st RR). Players in this event can expect to play 8 to 10 matches. This event is limited to the first 36 players who sign up on a first come first serve basis. Doors open on Saturday at 9:00AM. Tournament will start at 10:00AM. Ratings will be based on the August 31st, 2008 USATT Ratings.

The tournament committee's decision is final.
